

CORRIGENDUM I TO THE NOTICE OF THE EXTRAORDINARY GENERAL MEETING TO BE HELD ON WEDNESDAY, OCTOBER 15, 2025 AT 11.00 A.M.

This Corrigendum I is being issued by M/s. ACS Technologies Limited ("Company") for convening an Extra-Ordinary General Meeting of the Members of the Company ("EGM") on Wednesday, October 15, 2025 at 11:00 A.M. through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM"). This Corrigendum I is to be read in conjunction with the EGM Notice dated September 22, 2025 as available on the websites of the Company, and BSE Limited ("BSE"). The Notice of the EGM was dispatched to all the shareholders of the Company in due compliance with the provisions of the Companies Act, 2013, and rules made thereunder, read with circulars issued by Ministry of Corporate Affairs and Securities and Exchange Board of India and all other applicable provisions.
